Description

A set of gene names may have been used to report yeast genes represented by ORF identifiers. One of these names is chosen to be the primary gene name, and the others are considered aliases. This R object provides mappings between the primary name and aliases.

Details

Each primary name maps to a vector of alias names. If there are no aliases, the vector will contain NA.

Map Manufacturer IDs to Chromosomes

Description

ygs98CHR is an R object that provides mappings between a manufacturer identifier and the chromosome that contains the gene of interest.

Details

Each manufacturer identifier maps to a vector of chromosomes. Due to inconsistencies that may exist at the time the object was built, the vector may contain more than one chromosome (e.g., the identifier may map to more than one chromosome). If the chromosomal location is unknown, the vector will contain an NA.

A named vector for the length of each of the chromosomes

Description

ygs98CHRENGTHS provides the length measured in base pairs for each of the chromosomes.

Details

This is a named vector with chromosome numbers as the names and the corresponding lengths for chromosomes as the values.

Total lengths of chromosomes were derived by calculating the number of base pairs on the sequence string for each chromosome.

`ygs98CHRLOC`*Map Manufacturer IDs to Chromosomal Location*

Description

`ygs98CHRLOC` is an R object that maps manufacturer identifiers to the starting position of the gene. The position of a gene is measured as the number of base pairs.

The `CHRLOCEND` mapping is the same as the `CHRLOC` mapping except that it specifies the ending base of a gene instead of the start.

Details

Each manufacturer identifier maps to a named vector of chromosomal locations, where the name indicates the chromosome. Due to inconsistencies that may exist at the time the object was built, these vectors may contain more than one chromosome and/or location. If the chromosomal location is unknown, the vector will contain an NA.

Chromosomal locations on both the sense and antisense strands are measured as the number of base pairs from the p (5' end of the sense strand) to q (3' end of the sense strand) arms. Chromosomal locations on the antisense strand have a leading "-" sign (e. g. -1234567).

Since some genes have multiple start sites, this field can map to multiple locations.

Details

ygs98ENZYME

Map between Manufacturer IDs and Enzyme Commission (EC) Numbers

Description

ygs98ENZYME is an R object that provides mappings between manufacturer identifiers and EC numbers.

Details

Each manufacturer identifier maps to a named vector containing the EC number that corresponds to the enzyme produced by that gene. The name corresponds to the manufacturer identifier. If this information is unknown, the vector will contain an NA.

Enzyme Commission numbers are assigned by the Nomenclature Committee of the International Union of Biochemistry and Molecular Biology <http://www.chem.qmw.ac.uk/iubmb/enzyme/> to allow enzymes to be identified.

An Enzyme Commission number is of the format EC x.y.z.w, where x, y, z, and w are numeric numbers. In ygs98ENZYME2PROBE, EC is dropped from the Enzyme Commission numbers.

Enzyme Commission numbers have corresponding names that describe the functions of enzymes in such a way that EC x is a more general description than EC x.y that in turn is a more general description than EC x.y.z. The top level EC numbers and names are listed below:

ygs98GO

*Map between Manufacturer IDs and Gene Ontology (GO)***Description**

ygs98GO is an R object that provides mappings between manufacturer identifiers and the GO identifiers that they are directly associated with.

Details

Each Entrez Gene identifier is mapped to a list of lists. The names on the outer list are GO identifiers. Each inner list consists of three named elements: GOID, Ontology, and Evidence.

The GOID element matches the GO identifier named in the outer list and is included for convenience when processing the data using 'lapply'.

The Ontology element indicates which of the three Gene Ontology categories this identifier belongs to. The categories are biological process (BP), cellular component (CC), and molecular function (MF).

The Evidence element contains a code indicating what kind of evidence supports the association of the GO identifier to the Entrez Gene id. Some of the evidence codes in use include:

IMP: inferred from mutant phenotype

IGI: inferred from genetic interaction

IPI: inferred from physical interaction

ISS: inferred from sequence similarity

IDA: inferred from direct assay

IEP: inferred from expression pattern

IEA: inferred from electronic annotation

TAS: traceable author statement

NAS: non-traceable author statement

ND: no biological data available

IC: inferred by curator

Description

ygs98GO2ALLPROBES is an R object that provides mappings between a given GO identifier and all manufacturer identifiers annotated at that GO term or one of its children in the GO ontology.

Details

GO consists of three ontologies—molecular function (MF), biological process (BP), and cellular component (CC). All ontologies are structured as directed acyclic graphs (DAGs). Each node in each DAG (tree) is a GO term (id) associated with a named vector of manufacturer identifiers. The name associated with each manufacturer id corresponds to the evidence code for that GO identifier. This object ygs98GO2ALLPROBES maps between a given GO identifier and all manufacturer identifiers annotated at that GO term or one of its children in the GO ontology.

The evidence code indicates what kind of evidence supports the association between the GO and Entrez Gene identifiers. Evidence codes currently in use include:

IMP - inferred from mutant phenotype
 IGI - inferred from genetic interaction
 IPI - inferred from physical interaction
 ISS - inferred from sequence similarity
 IDA - inferred from direct assay
 IEP - inferred from expression pattern

This "map count" information is precalculated and stored in the package annotation DB. This allows some quality control and is used by the [checkMAPCOUNTS](#) function defined in AnnotationDbi to compare and validate different methods (like `count.mappedkeys(x)` or `sum(!is.na(as.list(x)))`) for getting the "map count" of a given map.

The Organism information for ygs98

Description

ygs98ORGANISM is an R object that contains a single item: a character string that names the organism for which ygs98 was built. ygs98ORGPKG is an R object that contains a character vector with the name of the organism package that a chip package depends on for its gene-centric annotation.

Details

Although the package name is suggestive of the organism for which it was built, ygs98ORGANISM provides a simple way to programmatically extract the organism name. ygs98ORGPKG provides a simple way to programmatically extract the name of the parent organism package. The parent organism package is a strict dependency for chip packages as this is where the gene centric information is ultimately extracted from. The full package name will always be this string plus the extension ".db". But most programatic acces will not require this extension, so its more convenient to leave it out.

Details

Each KEGG pathway has a name and identifier. Pathway name for a given pathway identifier can be obtained using the KEGG data package that can either be built using AnnBuilder or downloaded from Bioconductor <http://www.bioconductor.org>.

Description

ygs98PATH2PROBE is an R object that provides mappings between KEGG identifiers and manufacturer identifiers.

Details

Each KEGG identifier is mapped to a named vector of manufacturer identifiers. The name represents the KEGG identifier and the vector contains all manufacturer identifiers that are found in that particular pathway. An NA is reported for any KEGG identifier that cannot be mapped to any manufacturer identifiers.

Pathway name for a given pathway identifier can be obtained using the KEGG data package that can either be built using AnnBuilder or downloaded from Bioconductor <http://www.bioconductor.org>.

Graphic presentations of pathways are searchable at <http://www.genome.ad.jp/kegg/pathway.html> using pathway identifiers as keys.

ygs98PMID is an R object that provides mappings between manufacturer identifiers and PubMed identifiers.

Details

Each manufacturer identifier is mapped to a named vector of PubMed identifiers. The name associated with each vector corresponds to the manufacturer identifier. The length of the vector may be one or greater, depending on how many PubMed identifiers a given manufacturer identifier is mapped to. An NA is reported for any manufacturer identifier that cannot be mapped to a PubMed identifier.

Titles, abstracts, and possibly full texts of articles can be obtained from PubMed by providing a valid PubMed identifier. The `pubmed` function of `annotate` can also be used for the same purpose.

Arguments

<code>file</code>	A connection, or a character string naming the file to print to (see the <code>file</code> argument of the <code>cat</code> function for the details).
<code>show.indices</code>	The CREATE INDEX statements are not shown by default. Use <code>show.indices=TRUE</code> to get them.

Details

`ygs98_dbconn` returns a connection object to the package annotation DB. **IMPORTANT:** Don't call `dbDisconnect` on the connection object returned by `ygs98_dbconn` or you will break all the `AnnDbObj` objects defined in this package!

`ygs98_dbfile` returns the path (character string) to the package annotation DB (this is an SQLite file).

`ygs98_dbschema` prints the schema definition of the package annotation DB.

`ygs98_dbInfo` prints other information about the package annotation DB.

Value

`ygs98_dbconn`: a `DBIConnection` object representing an open connection to the package annotation DB.

`ygs98_dbfile`: a character string with the path to the package annotation DB.

`ygs98_dbschema`: none (invisible NULL).

`ygs98_dbInfo`: none (invisible NULL).
